Muncul Hammer candle dengan RSI melemah dan MACD & volume perdagangan menurun serta Stochastic nya berpotensi Dead cross. Hari ini jika IHSG dibuka kembali menguat maka potensi menguji resist level terdekat di 6850-6890 an dan 6910-6948 an meski rawan profit taking dengan target IHSG terdekat di 6968 an. Namun jika IHSG dibuka kembali melemah maka potensi menguji support range terdekat di 6724-6800 an dengan potensi rebound dan area "bottom fishing" terdekat di area 6680-6690 an. Foreign flow kemarin tercatat Net SELL (RG): Rp1.01 tn sehingga secara kumulatif (YTD) tercatat Net SELL (RG): Rp39.17 tn dengan value transaksi harian Rp12.99 tn pada perdagangan kemarin.
